Each year the CSEA Board of Directors considers membership dues rates upon the Finance & Budget Committee's recommendation based on a report and recommendation from the Dues Subcommittee. During its January 10, 2016 meeting, the Board considered three dues-related motions presented by the Finance & Budget Committee that would:

- 1) Eliminate the initiation fee for new members
- 2) Eliminate all existing membership dues revenue-sharing policies and practices, with the exception of collection and distribution of chapter dues
- 3) Revise membership dues
